

The company's leadership was determined to remain close to their established workforce, making relocation boundaries narrow and viable alternatives scarce.

Compounding the challenge was a complex ownership and sale structure that required careful navigation and creative negotiation. Aligning the timing, financial expectations, and objectives of multiple parties demanded deep market insight, patience, and strategic guidance. The goal was to position the client for long-term stability while overcoming the constraints of both the market and the transaction's unique structure
